Please note from 01 July 2022, Clinical Commissioning Groups (CCGs) were disestablished, and their statutory functions and responsibilities inherited by NHS Cheshire and Merseyside ICB.

Your Request:

1) What did your ICB spend on delivery of the tobacco dependence treatment programme in maternity, mental health inpatient and acute inpatient in the financial year 2021/22 in each Trust?

Our Response:

- 1) Please note that prior to the creation of NHS Cheshire & Merseyside ICB on 01 July 2022, the tobacco dependance treatment programme was managed by Cheshire & Merseyside Health Care Partnership hosted by Liverpool University Teaching Hospital NHS Foundation Trust. - Liverpool University Hospitals NHS Foundation Trust: £421,000.
- Mid Cheshire Hospitals NHS Foundation Trust: £46,500.
- Wirral University Teaching Hospital NHS Foundation Trust: £20,000.

3) What is the allocated budget for delivery of the tobacco dependence treatment programme in maternity, mental health inpatient and acute inpatient for the financial year 2023/24 in each Trust?

3) NHS Cheshire & Merseyside ICB has received a total allocation of £1,464,000 for tobacco dependance treatment programmes for the 2023/24 financial year. Individual allocations of this total to individual NHS Trusts are currently being finalised, based on inpatient numbers.

4) What is the planned budget for delivery of the tobacco dependence treatment programme in maternity, mental health inpatient and acute inpatient for the financial year 2024/25 in each Trust?

Our Response:

4) NHS Cheshire & Merseyside ICB's allocation/budget for tobacco dependance treatment programmes during the 2024/25 financial year has not yet been confirmed.

5) In the financial year 2023/24 is their allocated budget for any other smoking cessation activity within the ICB across NHS Trusts e.g. NHS staff, community mental health, outpatients and what is that allocated budget?

Our Response:

5) NHS Cheshire & Merseyside ICB has not allocated any other budgets for other smoking cessation activity within NHS Trusts.
