Thank you for your information request indicated in bold below, which has now been considered under the Freedom of Information Act 2000 by NHS Cheshire & Merseyside Integrated Care Board (ICB). I am able to provide you with the following information and responses.

Your Request:

- 1) Cost what is it per head of population and how much / if block contract for how much total and how many patients within the provider population
- 2) Who it is provided by at that place
- 3) Does it cover hospital outpatient blood request and if so which ones are included / excluded is this and additional payment and if so how much
- 4) Are consumables supplied or have to be bought by provider
- 5) Expected wait time for appointments under the contract for routine bloods
- 6) Any expected delivery maximum or minimum delivery per head of population

Our Response:

Please find listed below the requested information held regarding phlebotomy Service Contracts in each of the former CCG areas that now make up NHS Cheshire & Merseyside ICB:

Cheshire

- 1 2) Please find listed below the providers of phlebotomy services across Cheshire, broken down by each former CCG area, along with the calculated cost per patient per annum (where known):
- General Practice (GP): £0.52.
- Vernova CIC: £0.52.

Phlebotomy services are also commissioned via a block contract for a range of healthcare services from the below NHS Trusts with no specifically defined spend on the phlebotomy service provision:

- Mid Cheshire Hospitals NHS Foundation Trust
- Countess of Chester Hospital NHS Foundation Trust
- Wirral University Teaching Hospitals NHS Foundation Trust
- 3) The above hospitals provide their own internal acute phlebotomy services, as well as capacity to provide community phlebotomy.
- 4) Consumables are purchased by the providers.
- 5 6) Non specified.

Halton

- 1) Phlebotomy services are commissioned via a block contract for a range of healthcare services, with no specifically defined spend on the phlebotomy service provision.
- 2) Phlebotomy services are commissioned in Halton from *St Helens & Knowsley Teaching Hospitals NHS Trust* and *Warrington & Halton Teaching Hospitals NHS Foundation Trust*.
- 3) The above hospitals provide their own internal acute phlebotomy services, as well as community phlebotomy.
- 4) Consumables are purchased by the provider.
- 5) Generally 2 days and a maximum of a week.
- 6) No.

Knowsley

- 1) Phlebotomy services are commissioned via a block contract for a range of healthcare services, with no specifically defined spend on the phlebotomy service provision.
- 2) Phlebotomy services are commissioned from *Alder Hey Children's Hospital NHS Foundation Trust* (under 18s) and *Mersey Care NHS Foundation Trust* (over 18's).
- 3) The above phlebotomy services are community services which are delivered outside of the acute hospital setting.
- 4) Consumable are included as part of the overall block contract payment.
- 5) Currently the average waiting time for a routine appointment is 48 hours.
- 6) The only expected delivery time specified for the phlebotomy service contracts is urgent bloods should be seen within 24 hours.

Liverpool

- 1) Cost per patient was £3.26 based on the 2022/23 contracts for phlebotomy services.
- 2) Phlebotomy services are commissioned from *Mersey Care NHS Foundation Trust* (clinics/domiciliary) as well as within GP Practices in Liverpool.
- 3) No.
- 4) Consumables are purchased by the provider.
- 5) Mersey Care NHS Foundation Trust, 10 days for routine bloods.
- 6) Expected activity level per annum per provider. Mersey Care NHS Foundation Trust is the prime provider of phlebotomy in Liverpool under a block contract arrangement. General Practices supplement the Mersey Care NHS Foundation Trust capacity in the city with a maximum level of activity specified.

Sefton

- 1) Phlebotomy services are commissioned with the provider via a block contract for a range of healthcare services, with no specifically defined spend on the phlebotomy service provision. Additionally, GP Practices also provide phlebotomy services at a cost of £2.70 per venepuncture.
- 2) Phlebotomy services are commissioned from *Mersey Care NHS Foundation Trust* (clinics/domiciliary) as well as within GP Practices in Sefton.
- 3) No. Hospitals are paid under national tariff arrangements for all diagnostic activity undertaken.
- 4) Consumables are purchased by the provider.
- 5) Mersey Care NHS Foundation Trust is 10 days for routine bloods and for General Practice's offering an appointment system should offer an appointment within 48 hours.
- 6) There is an expected activity level with Merseycare NHS Foundation Trust. For General Practice there is none.

St Helens

- 1) The total cost of community phlebotomy services in St Helens is £223,790 per annum, with a cost per head of population of £1.13 and a registered population of 197,590.
- 2) Phlebotomy services are commissioned in St Helens from *St Helens & Knowsley Teaching Hospitals NHS Trust*.
- 3) The phlebotomy services commissioned from St Helens & Knowsley Teaching Hospitals provides services within Whiston and St Helens hospitals, as well as in the community.
- 4) Consumables are sourced by provider.
- 5) Routine referrals are expected to be seen within 10 days.
- 6) No.

Warrington

- 1) Phlebotomy services are commissioned via a block contract for a range of healthcare services, with no specifically defined spend on the phlebotomy service provision.
- 2) Phlebotomy services are commissioned in Warrington from *Bridgewater Community Healthcare NHS Foundation Trust* and *Warrington & Halton Teaching Hospitals NHS Foundation Trust*.
- 3) No, hospital outpatient blood requests are part of the nationally agreed tariff charges.
- 4) Consumables are purchased by the providers.
- 5 6) Non specified.

Wirral

- 1) £2.176 per patient based on weighted population 377,817. Total registered population of Wirral 339,545. Block payment arrangement £822,274. In addition, £64,958 is provided for hospital bloods taken in the community by practices, therefore total contract value is £887,232 up to June 2023.
- 2) Phlebotomy services are commissioned via GP practices in Wirral.
- 3) There is an additional payment to GP practices annually for hospital bloods undertaken in general practice, currently this is £64,958 in total. The total

contract value was £887,232 up to June 2023. Hospital bloods excluded from the community service due to specialised handling include:

- Aldosterone/Renin lithium heparin blood collecting bottle (green top)
- Insulin/c-peptide Serum separator tube (ochre top) collected on ice
- Gut hormones EDTA blood collecting tube (collected on ice)
- Lactate Fluoride blood collecting tube (grey top)
- White cell enzymes EDTA blood collecting tube
- ACTH EDTA blood collecting tube
- Calcitonin Serum separator tube (ochre top) collected on ice
- CTX EDTA blood collecting tube
- Homocysteine EDTA blood collecting tube
- GTT for pregnancy (maternity and clinic 5 can undertake these)
- Less frequent tests i.e. those needing to be with the lab within a certain timeframe, need to be on ice etc.
- 4) Consumables are inclusive of the contract funding.
- 5) Please find listed below the current expected wait times for urgent/routine bloods:

Referral Type	Referral to Testing
Routine Referral	Within 5 working days from referral
Urgent Referral	Within 2 working days from referral
