# Re: Freedom of Information Act 2000 Intrauterine insemination (IUI) for Same Sex Couples

Thank you for your information request indicated in bold below, which has now been considered under the Freedom of Information Act 2000 by NHS Cheshire & Merseyside Integrated Care Board (ICB). I am able to provide you with the following information and responses.

Please note from 01 July 2022, Clinical Commissioning Groups (CCGs) were disestablished, and their statutory functions and responsibilities inherited by NHS Cheshire and Merseyside ICB.

### Your Request:

The Women's Health Strategy (updated 30 August 2022) published by the Department for Health and Social Care outlines priority areas that require targeted action: <a href="Women's Health Strategy for England - GOV.UK">Women's Health Strategy for England - GOV.UK</a> (www.gov.uk)

Of these key priority areas, section 12 includes fertility, specifically, unequal access to fertility services for same-sex female couples: "We will relieve those additional burdens, so that there is no requirement for self-funding and the NHS treatment pathway for female same-sex couples will start with 6 cycles of artificial insemination, prior to accessing IVF services if necessary."

When will the Cheshire and Merseyside ICB implement the guidance surrounding funded IUI for same-sex couples as per the Women's Health Strategy?
