## Meningococcal Group A, C, W, and Y Conjugate Vaccine for Risk Groups Patient Group Direction (PGD)

This PGD is for the administration of meningococcal group A, C, W, and Y conjugate vaccine (MenACWY) to individuals with an underlying medical condition which puts them at increased risk from *Neisseria meningitidis*.

This PGD is for the administration of MenACWY vaccine by registered healthcare practitioners identified in [Section 3](#), subject to any limitations to authorisation detailed in [Section 2](#).

**The UK Health Security Agency (UKHSA) has developed this PGD to facilitate the delivery of publicly funded immunisation in England line with national recommendations.**

Those using this PGD must ensure that it is organisationally authorised and signed in Section 2 by an appropriate authorising person, relating to the class of person by whom the product is to be supplied, in accordance with Human Medicines Regulations 2012 (HMR2012)<sup>1</sup>. **The PGD is not legal or valid without signed authorisation in accordance with [HMR2012 Schedule 16 Part 2](#).**

Authorising organisations must not alter, amend or add to the clinical content of this document (sections 4, 5 and 6); such action will invalidate the clinical sign-off with which it is provided. In addition, authorising organisations must not alter section 3 'Characteristics of staff'. Only sections 2 and 7 can be amended within the designated editable fields provided.

Operation of this PGD is the responsibility of commissioners and service providers. The final authorised copy of this PGD should be kept by the authorising organisation completing Section 2 for 8 years after the PGD expires if the PGD relates to adults only and for 25 years after the PGD expires if the PGD relates to children only, or adults and children. Provider organisations adopting authorised versions of this PGD should also retain copies for the periods specified above.



<p><b>Continued training requirements</b></p>	<p>Practitioners must ensure they are up to date with relevant issues and clinical skills relating to immunisation and management of anaphylaxis, with evidence of appropriate Continued Professional Development (CPD).</p> <p>Practitioners should be constantly alert to any subsequent recommendations from the UKHSA, NHSE and other sources of medicines information.</p> <p>Note: The most current national recommendations should be followed, but a Patient Specific Direction (PSD) may be required to administer the vaccine in line with updated recommendations that are outside the criteria specified in this PGD.</p>

#### 4. Clinical condition or situation to which this PGD applies

<p><b>Clinical condition or situation to which this PGD applies</b></p>	<p>Indicated for the active immunisation of individuals with an underlying medical condition which puts them at increased risk from <i>Neisseria meningitidis</i> groups A, C, W and Y, in accordance with the recommendations given in <a href="#">Chapter 7</a> and <a href="#">Chapter 22</a> of Immunisation Against Infectious Disease: 'The Green Book'.</p>
<p><b>Criteria for inclusion</b></p>	<p>Individuals who:</p> <ul style="list-style-type: none"> <li>• are at increased risk of invasive meningococcal infection with asplenia, splenic dysfunction, or complement disorders (including those on, or due to commence complement inhibitor treatment, such as eculizumab (Soliris®) and ravulizumab (Ultomiris®)</li> </ul> <p>Note: This includes individuals with medical conditions accompanied by functional hyposplenism (such as sickle cell disease), but does not include those with coeliac disease unless concurrent hyposplenism has been diagnosed.</p>
<p><b>Criteria for exclusion<sup>2</sup></b></p>	<p>Individuals for whom no valid consent has been received</p> <p>Individuals who:</p> <ul style="list-style-type: none"> <li>• have had a confirmed anaphylactic reaction to a previous dose of the vaccine or to any constituent or excipient of the vaccine, including diphtheria toxoid, CRM<sub>197</sub> carrier protein (Menveo®) and tetanus toxoid (Nimenrix® and MenQuadfi®)</li> <li>• have received MenACWY conjugate vaccine over 1 year of age and in the last 12 months (excluded as they are adequately immunised)</li> <li>• presenting at one year to under 2 years of age and have had a dose of Hib/ MenC in the last 8 weeks</li> <li>• are not at increased risk of invasive meningococcal infection and require routine MenACWY vaccination</li> <li>• are a contact of an individual diagnosed with <i>Neisseria meningitidis</i> groups A, C, W and Y disease.</li> <li>• require vaccination for occupational health reasons such as laboratory workers working with meningococci</li> <li>• require vaccination for the purpose of travel</li> <li>• are suffering from acute severe febrile illness (the presence of a minor infection is not a contraindication for immunisation)</li> </ul>
<p><b>Cautions including any relevant action to be taken</b></p> <p>(continued over page)</p>	<p>Facilities for management of anaphylaxis should be available at all vaccination sites (see <a href="#">Chapter 8</a> of the Green Book) and advice issued by the <a href="#">Resuscitation Council</a> UK.</p> <p>The immunogenicity of the vaccine could be reduced in immunosuppressed subjects. However, vaccination should proceed in accordance with national recommendations.</p> <p>Where possible, vaccines should be administered 2 weeks before immunosuppressive treatment begins, before immunosuppression occurs, or deferred until an improvement in immunity is seen.</p> <p>Syncope (fainting) can occur following, or even before, any vaccination especially in adolescents as a psychogenic response to the needle injection. This can be accompanied by several neurological signs such as transient visual disturbance, paraesthesia and tonic-clonic limb</p>

<p><b>Cautions including any relevant action to be taken</b></p> <p>(continued)</p>	<p>movements during recovery. It is important that procedures are in place to avoid injury from faints.</p>
<p><b>Action to be taken if the patient is excluded</b></p>	<p>Individuals who have received MenACWY conjugate vaccine over 1 year of age and in the last 12 months do not require a further dose of MenACWY conjugate vaccine when diagnosed at risk.</p> <p>Individuals aged 1 year of age should receive MenACWY vaccine at least 8 weeks after their Hib/MenC vaccine.</p> <p>Individuals who are not at increased risk of invasive meningococcal infection and require routine MenACWY vaccination or who are a contact of <i>Neisseria meningitidis</i> groups A, C, W and Y disease, should be vaccinated in accordance with UKHSA recommendations (see <a href="#">MenACWY PGD</a>).</p> <p>Individuals requiring vaccination for occupational health reasons, such as laboratory workers working with meningococci, should be referred to their occupational health service provider for vaccination.</p> <p>Individuals requiring vaccination solely for the purpose of travel should be referred to the appropriate travel immunisation service. MenACWY vaccine is not available on the NHS for the purpose of travel.</p> <p>Individuals suffering from acute severe febrile illness should postpone immunisation until they have recovered. Immunisers should advise when the individual can be vaccinated and ensure another appointment is arranged.</p> <p>Seek appropriate advice from the local Screening and Immunisation Team, local Health Protection Team or the individual's clinician as required.</p> <p>The risk to the individual of not being immunised must be taken into account.</p> <p>Document the reason for exclusion and any action taken in the individual's clinical records.</p> <p>Inform or refer to the individual's GP or a prescriber as appropriate.</p>
<p><b>Action to be taken if the patient or carer declines treatment</b></p>	<p>Informed consent, from the individual or a person legally able to act on the person's behalf, must be obtained for each administration.</p> <p>Advise the individual, parent or carer about the protective effects of the vaccine, the risks of infection and potential complications of disease.</p> <p>Document advice given and the decision reached.</p> <p>Inform or refer to the individual's GP or a prescriber as appropriate.</p>

<p><b>Name, strength and formulation of drug</b></p>	<p>Meningococcal group A, C, W and Y conjugate vaccine, MenACWY:</p> <p><b>Menveo®</b>, 0.5ml reconstituted vaccine solution containing:</p> <p>Originally contained in powder vial:</p> <ul style="list-style-type: none"> <li>• Meningococcal group A oligosaccharide<sup>1</sup> 10micrograms</li> </ul> <p>Originally contained in the solution vial:</p> <ul style="list-style-type: none"> <li>• Meningococcal group C oligosaccharide<sup>1</sup> 5 micrograms</li> <li>• Meningococcal group W135 oligosaccharide<sup>1</sup> 5 micrograms</li> <li>• Meningococcal group Y oligosaccharide<sup>1</sup> 5 micrograms</li> </ul> <p><sup>1</sup>conjugated to <i>Corynebacterium diphtheriae</i> CRM<sub>197</sub> protein</p> <p>or</p> <p><b>Nimenrix®</b>, 0.5ml reconstituted vaccine solution containing:</p> <p>Originally in powder:</p> <ul style="list-style-type: none"> <li>• <i>Neisseria meningitidis</i> A polysaccharide<sup>2</sup> 5 micrograms</li> <li>• <i>Neisseria meningitidis</i> C polysaccharide<sup>2</sup> 5 micrograms</li> <li>• <i>Neisseria meningitidis</i> W135 polysaccharide<sup>2</sup> 5 micrograms</li> <li>• <i>Neisseria meningitidis</i> Y polysaccharide<sup>2</sup> 5 micrograms</li> </ul> <p><sup>2</sup> conjugated to tetanus toxoid carrier protein 44 micrograms</p> <p>Solvent for solution for injection in pre-filled syringe</p> <p>or</p> <p><b>MedQuadfi®</b>, 0.5ml solution for injection containing:</p> <ul style="list-style-type: none"> <li>• <i>Neisseria meningitidis</i> group A polysaccharide<sup>3</sup> 10 micrograms</li> <li>• <i>Neisseria meningitidis</i> group C polysaccharide<sup>3</sup> 10 micrograms</li> <li>• <i>Neisseria meningitidis</i> group W polysaccharide<sup>3</sup> 10 micrograms</li> <li>• <i>Neisseria meningitidis</i> group Y polysaccharide<sup>3</sup> 10 micrograms</li> </ul> <p><sup>3</sup> conjugated to tetanus toxoid carrier protein 55 micrograms</p>
<p><b>Legal category</b></p>	<p>Prescription only medicine (POM)</p>
<p><b>Black triangle ▼</b></p>	<p>MedQuadfi®. As a new vaccine product, the Medicines and Healthcare products Regulatory Agency (MHRA) has a specific interest in the reporting of adverse drug reactions for this product. All suspected adverse drug reactions should be reported using the <a href="#">MHRA Yellow Card Scheme</a>.</p>
<p><b>Off-label use</b> (continued over page)</p>	<p>Administration by deep subcutaneous injection to individuals with a bleeding disorder is off-label administration in line with advice in <a href="#">Chapter 4</a> and <a href="#">Chapter 22</a> of 'The Green Book'.</p> <p>Menveo® is off-label for children under 2 years of age, as is MenQuadfi® for children under 12 months.</p> <p>Nimenrix® is licensed from 6 weeks of age, for a schedule with a minimum 2 month interval between doses.</p> <p>Where possible, administer a vaccine licensed for the age of the individual. If no licenced vaccine is available, then an alternative vaccine may be given off-label to avoid undue delay.</p> <p>All vaccines are recommended in accordance with advice in <a href="#">Chapter 7</a> and <a href="#">Chapter 22</a> of 'The Green Book'.</p> <p>Vaccine should be stored according to the conditions detailed in the <a href="#">Storage section</a> below. However, in the event of an inadvertent or unavoidable deviation of these conditions, refer to <a href="#">Vaccine Incident</a></p>

<p><b>Off-label use</b> (continued)</p>	<p><a href="#">Guidance</a>. Where vaccine is assessed in accordance with these guidelines as appropriate for continued use, this would constitute off-label administration under this PGD.</p> <p>Where a vaccine is recommended off-label, consider, as part of the consent process, informing the individual/parent/carer that the vaccine is being offered in accordance with national guidance but that this is outside the product licence.</p>
<p><b>Route and method of administration</b></p>	<p>Menveo® and Nimenrix® must be reconstituted in accordance with the manufacturer’s instructions prior to administration.</p> <p>All components of these vaccines should be visually inspected before and after reconstitution. It is recommended that these vaccines are administered immediately after reconstitution, to minimise loss of potency. Discard reconstituted vaccine if it is not used within 8 hours</p> <p>All vaccines should be inspected immediately prior to administration.</p> <p>In the event of observing any foreign particulate matter or difference in expected physical appearance of either the vaccine components or final product, discard the vaccine (see <a href="#">Storage</a> section).</p> <p>MenACWY conjugate vaccine should be given as a single 0.5ml dose by intramuscular injection, preferably in the deltoid region of the upper arm. The anterolateral aspect of the thigh is the preferred site for infants under one year old.</p> <p>The MenACWY conjugate vaccines must not be given intravascularly or intradermally and must not be mixed with other vaccines in the same syringe.</p> <p>For individuals with a bleeding disorder, vaccines normally given by an IM route should be given by deep subcutaneous injection to reduce the risk of bleeding (see ‘The Green Book’ <a href="#">Chapter 4</a>).</p> <p>When administering at the same time as other vaccines, care should be taken to ensure that the appropriate route of injection is used for all the vaccinations. The vaccines should be given at separate sites, preferably in different limbs. If given in the same limb, they should be given at least 2.5cm apart. The site at which each vaccine was given should be noted in the individual’s records.</p> <p>The SPCs for Menveo®, Nimenrix® and MenQuadfi® provide further guidance on vaccine handling and administration and are available from the <a href="#">electronic Medicines Compendium</a>.</p>
<p><b>Dose and frequency of administration</b> (continued over page)</p>	<p><b>Individuals first diagnosed or presenting under 1 year of age</b></p> <p>Individuals, with asplenia, splenic dysfunction or complement disorders, should receive:</p> <ul style="list-style-type: none"> <li>• 2 primary doses of MenACWY vaccine at least 4 weeks apart during their first year, and</li> <li>• one booster dose of MenACWY vaccine after the first birthday.</li> </ul> <p>This dose should be administered at least 8 weeks after the routine vaccines scheduled at 1 year of age, to further boost the immune response to the MenC component of Hib/MenC.</p> <p>Where possible, the course should be completed with the same brand of MenACWY vaccine. However, vaccination should not be delayed and any of the licensed vaccines may be used.</p>

<p><b>Dose and frequency of administration</b></p> <p>(continued)</p>	<p><b>Individuals first diagnosed or presenting over 1 year of age</b></p> <p>Individuals over 1 year of age, with asplenia, splenic dysfunction or complement disorders, require a single dose of MenACWY vaccine on presentation, at least 8 weeks after vaccination with Hib/MenC.</p> <p>Refer to Green Book <a href="#">Chapter 7</a> for a practical schedule for immunising individuals with asplenia, splenic dysfunction or complement disorders, which takes into account the other vaccines required by these individuals.</p>
<p><b>Duration of treatment</b></p>	<p>See dose section above</p>
<p><b>Quantity to be supplied and administered</b></p>	<p>Single dose of 0.5ml per administration</p>
<p><b>Supplies</b></p>	<p>Vaccine for the national immunisation programme should not be used for the vaccination of at-risk individuals. Vaccine should be ordered from the manufacturer.</p> <p>Protocols for the ordering, storage and handling of vaccines should be followed to prevent vaccine wastage (see Green Book <a href="#">Chapter 3</a>).</p>
<p><b>Storage</b></p>	<p>Store between +2°C to +8°C. Store in original packaging to protect from light.</p> <p>Do not freeze.</p> <p>In the event of an inadvertent or unavoidable deviation of these conditions, vaccine that has been stored outside the conditions stated above should be quarantined and risk assessed for suitability of continued off-label use or appropriate disposal. Refer to <a href="#">Vaccine Incident Guidance</a>.</p> <p>After reconstitution of Menveo® and Nimenrix®, the vaccine should be used immediately. However, stability after reconstitution has been demonstrated for 8 hours below 25°C (below 30°C for Nimenrix®). Discard any reconstituted vaccine not used within 8 hours.</p> <p>MenQuadfi® stability data indicates the vaccine may be used up to 72 hours following exposure to temperatures up to 25°C.</p>
<p><b>Disposal</b></p>	<p>Equipment used for immunisation, including used vials, ampoules, or discharged vaccines in a syringe or applicator, should be disposed of safely in a UN-approved puncture-resistant 'sharps' box, according to local authority arrangements and NHSE guidance (<a href="#">HTM 07-01: Management and disposal of healthcare waste</a>).</p>
<p><b>Drug interactions</b></p>	<p>Immunological response may be diminished in individuals receiving immunosuppressant treatment. Vaccination is recommended even if the antibody response may be limited.</p> <p>May be given at the same time as other vaccines.</p>

<p><b>Identification and management of adverse reactions</b></p> <p>(continued)</p>	<p><b>Nimenrix®</b></p> <p>The most common adverse reactions observed after administration of Nimenrix® vaccine are drowsiness, fatigue, headache, irritability, fever and injection site pain, erythema and induration and loss of appetite, Gastro-intestinal symptoms (including nausea, vomiting and diarrhoea) and injection site haematoma are also listed as common side effects.</p> <p><b>MedQuadfi®</b></p> <p>The most common adverse reactions observed after administration of MenQuadfi® vaccine are malaise, headache, myalgia and injection site pain. Fever and injection site induration and erythema are also listed as common side effects.</p> <p>A detailed list of adverse reactions associated with Menveo®, Nimenrix® and MenQuadfi® are available in the SPCs for the vaccines, which are available from the <a href="#">electronic Medicines Compendium</a>.</p>
<p><b>Reporting procedure of adverse reactions</b></p>	<p>Healthcare professionals and individuals, parents and carers are encouraged to report suspected adverse reactions to the Medicines and Healthcare products Regulatory Agency (MHRA) using the scheme or searching for MHRA Yellow Card in the Google Play or Apple App Store.</p> <p>Any adverse reaction to the vaccine should be documented in the individual's record and the individual's GP should be informed.</p>
<p><b>Written information to be given to patient or carer</b></p>	<p>Offer marketing authorisation holder's patient information leaflet (PIL) provided with the vaccine.</p> <p>Immunisation promotional material may be provided as appropriate:</p> <ul style="list-style-type: none"> <li>• <a href="#">Splenectomy leaflet</a></li> </ul>
<p><b>Patient advice and follow up treatment</b></p>	<p>Menveo®, Nimenrix® or MenQuadfi® will only confer protection against <i>Neisseria meningitidis</i> group A, C, W and Y. The vaccine will not protect against any other <i>Neisseria meningitidis</i> groups. Individuals should continue to seek prompt medical attention at the first signs of possible meningitis or septicaemia.</p> <p>Inform the individual, parent or carer of possible side effects and their management.</p> <p>The individual, parent or carer should be advised to seek medical advice in the event of a severe adverse reaction.</p> <p>When applicable, advise the individual, parent or carer when a subsequent dose is due.</p> <p>When administration is postponed, advise the individual, parent or carer when to return for vaccination.</p>
<p><b>Special considerations and additional information</b></p> <p>(continued over page)</p>	<p>Ensure there is immediate access to adrenaline (epinephrine) 1 in 1000 injection and access to a telephone at the time of vaccination.</p> <p>Medical conditions such as coeliac disease, sickle cell disease and other haemoglobinopathies may be accompanied by functional hyposplenism. However, hyposplenism in coeliac disease is uncommon in children, and the prevalence correlates with the duration of exposure to gluten. Therefore, individuals diagnosed with coeliac disease early in life and well managed are unlikely to require additional MenACWY vaccine.</p> <p>Only those with known splenic dysfunction should be vaccinated in accordance with this PGD.</p>

<p><b>Special considerations and additional information</b> (continued)</p>	<p>Individuals receiving complement inhibitor therapy (for example, eculizumab, ravulizumab) are at heightened risk of meningococcal infection and should be vaccinated with both MenACWY and MenB vaccines (see <a href="#">MenB Risk Groups PGD</a>), ideally at least 2 weeks prior to commencement of therapy.</p> <p>Meningococcal vaccines may be given to pregnant women when clinically indicated. There is no evidence of risk from vaccinating pregnant women or those who are breast-feeding with inactivated virus or bacterial vaccines or toxoids</p> <p>Each brand of vaccine uses a different carrier protein and the healthcare professional should refer to the SPCs supplied with the vaccine if there has been a previous hypersensitivity reaction to vaccination.</p>
<p><b>Records</b></p>	<p>Record:</p> <ul style="list-style-type: none"> <li>• that valid informed consent was given</li> <li>• name of individual, address, date of birth and GP with whom the individual is registered</li> <li>• name of immuniser</li> <li>• name and brand of vaccine</li> <li>• date of administration</li> <li>• dose, form and route of administration of vaccine</li> <li>• quantity administered</li> <li>• batch number and expiry date</li> <li>• anatomical site of vaccination</li> <li>• advice given, including advice given if excluded or immunisation declined</li> <li>• details of any adverse drug reactions and actions taken</li> <li>• supplied via PGD</li> </ul> <p>Records should be signed and dated (or a password-controlled immuniser's record on e-records).</p> <p>All records should be clear, legible and contemporaneous.</p> <p>This information should be recorded in the individual's GP record. Where vaccine is administered outside the GP setting, appropriate health records should be kept and the individual's GP informed.</p> <p>The local Child Health Information Services team (Child Health Records Department) must be notified using the appropriate documentation/pathway as required by any local or contractual arrangement.</p> <p>A record of all individuals receiving treatment under this PGD should also be kept for audit purposes in accordance with local policy.</p>
